On Tuesday, October 28, 2014 at approximately 6:33 AM, I, Deputy Butler, responded to 11 Old Kings Road North (Palm Coast Lanes), Palm Coast, in reference to assisting St. Petersburg Police Department (SPPD), who had issued a "be on the lookout" (BOLO) for a Darryl Allen Warren (suspect) last seen driving a blue 2004 Chevrolet Cavalier bearing FL tag # 814NRJ.

Upon my arrival, I observed the Chevrolet Cavalier bearing FL tag # 814NRJ parked in the center of the parking lot of Palm Coast Lanes with the driver's side door ajar and hood up and a black male wearing a baseball-style hat, gray button down shirt (gray undershirt), blue jeans (with athletic shorts underneath), and black shoes, later identified as Darryl, standing outside the vehicle. At that time, Darryl was secured for officer safety without incident and patted down for weapons (none being located). SPPD Detective Newton was contacted who confirmed to hold Darryl as a person of interest in the case, at which time Darryl was transported to FCSO Investigative Services Division (ISD) without incident. It should be noted, as soon as Darryl was escorted to the rear of my marked patrol vehicle, he became unresponsive (breathing) and had to be assisted into the rear of my marked patrol vehicle. Darryl's person was then searched with no weapons being located on his person (shoes and other property removed). John's Towing responded to the scene and transported the sealed vehicle to FCSO impound lot.

Upon arrival at FCSO ISD, D/S Breckwoldt assisted me in transferring Darryl (still unresponsive and breathing) from the rear of my marked patrol vehicle in to ISD Interrogation Room #2. As D/S Breckwoldt assisted me in transferring Darryl into ISD, Darryl's jeans slid from his waist due to him dragging his feet. Flagler County Rescue 92 responded to ISD in reference to medically evaluating Darryl (no medical emergencies detected). I then observed Darryl in ISD Interrogation Room #2 until approximately 11:45 AM when I responded to while I responded to the Flagler County Inmate Facility (FCIF) in order to obtain food for Darryl during which FCSO detectives observed Darryl and notified Flagler County Rescue 92 to respond and evaluate Darryl (no medical emergencies detected). Upon my return at approximately 12:05 PM, Darryl was offered the provided food; however, he continued to be unresponsive and breathing. I then observed Darryl until the arrival of SPPD detectives, and Darryl continued to be unresponsive and breathing. Upon confirmation, Darryl was placed under arrest in reference to an out-of-county warrant (# 14-18443-CF-1) out of Pinellas County for murder in the first degree entered on October 28, 2014 with no bond.

Flagler County Rescue 92 then responded to ISD and transported Darryl to Florida Hospital Flagler (FHF) for medical clearance without incident. I then observed Darryl until relieved by D/S Harvey. All paperwork and the scene were turned over to D/S Harvey.
