Summary/Highlights: The attached Resolution proposes to adopt a Final Ad Valorem (property tax) Millage Rate of 7.4500 (the proposed rate) for FY 2015/2016.

Background:

This is the last of two (2) required public hearings at which the Millage Rate for FY 2015/2016 will be considered. At the first public hearing held on Monday, September 14, 2015, the City Commission approved the tentative millage rate for FY 2015/2016 at a rate of 7.4500.

The Truth In Millage (TRIM) Bill requires that the Final Millage Rate be announced at the public hearing: Although the Final Millage Rate is the same as the previous year, the Final Millage Rate of 7.4500 is an increase of 7.49% from the Rolled-Back rate of 6.9309. The Rolled-Back Rate is the millage rate that will generate the same amount of ad valorem revenues as the prior year, less the value of new construction.

Staff Recommendation: Staff recommends approval of Resolution 2015-30: adopting a Final Ad Valorem Millage Rate of 7.4500 for FY 2015/2016.

RESOLUTION 2015-30

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF BUNNELL, FLAGLER COUNTY, FLORIDA ADOPTING A FINAL MILLAGE RATE FOR THE LEVY OF AD VALOREM TAXES FOR FISCAL YEAR 2015-2016 ON ALL TAXABLE PROPERTY LOCATED WITHIN THE CITY OF BUNNELL OF FLAGLER COUNTY, FLORIDA; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, The Flagler County Property Appraiser has certified the quantity of taxable property within the City of Bunnell for Fiscal Year 2015-2016; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within the City of Bunnell has been certified by the Flagler County Property Appraiser as of January 1, 2015; and

WHEREAS, the City Manager has delivered the Recommended Annual Operating Budget for FY 2015-2016 in accordance with Article IV, Section 4.04 of the City Charter; and

WHEREAS, the City Commission of the City of Bunnell, Flagler County, Florida, on September 14, 2015 adopted a tentative millage rate of 7.4500 following a public hearing as required by Florida Statute 200.065:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF BUNNELL, FLAGLER COUNTY, FLORIDA:

Section 1:

That the City Commission hereby adopts and imposes a final millage rate of 7.4500 for ad valorem taxation within the City of Bunnell, Flagler County, Florida for the 2015-2016 fiscal year. This final ad valorem tax shall be levied upon the 2015 Tax Assessment Roll for ad valorem tax on all taxable property located within the City of Bunnell and is to be used for the City's fiscal year beginning October 1, 2015 and ending September 30, 2016.

Section 2:

The ad valorem millage rate to be levied upon all taxable property located within the City of Bunnell is a 7.49% increase from the computed rolled-back rate of 6.9309.
