On 04/10/2015 at approximately 2333 hours I responded to the area of Wood Aspen Drive and Wood Acre Lane in reference to a noise complaint. The caller advised there were several vehicles in the area and that they could hear music coming from the wooded area behind the houses in the area.

Upon arrival deputies walked approximately ¼ mile into the woods and upon doing so found a group of approximately 15 young adults listening to music and drinking alcoholic beverages. Upon making contact with the subjects, I noticed that one of the subjects was a member of the Flagler County Sheriff's Office, Jonathan Kuleski. I asked Jonathan if everyone on scene was of legal age to drink and he advised he believed they were. Being that a Sheriff's Office employee was involved with the incident, Sergeant Williams was asked to respond to the scene to assist in the investigation. Sgt. Williams arrived on scene and units spoke with the subjects on scene.

In speaking with Jonathan, he advised that he was invited to the gathering at the above location by a male named Andre Rich, who was of legal drinking age. Jonathan advised that after he arrived at the gathering, a group of people arrived and had brought alcoholic beverages with them and began drinking what they had brought. Jonathan advised that he brought alcoholic beverages to the gathering for Alexandra Bogaert and himself, both of whom are of legal drinking age. Jonathan advised he was unaware that the property the gathering was on was private property and stated that had he known of that fact, he would not have gone to the gathering. Jonathan provided a sworn written statement in reference to the incident which will be submitted into records.

In speaking with several other subjects on scene, they confirmed Jonathan's story and advised that everyone at the gathering brought alcohol and that no one particular person supplied the alcoholic beverages. A male by the name Dalton Edwards advised that he was the person that arranged the gathering and that Jonathan was not involved in the planning of it. Dalton also provided a written statement in reference to what he advised and it will be submitted into records.

While on scene, a pair of brass knuckles were located on the tire of one of the vehicles. Initially, no one would claim to be the owner of the brass knuckles. Then several different people advised that the brass knuckles belonged to them. It was believed that the brass knuckles belonged to one of the subjects on scene, but due to several people claiming to own the item, they were simply seized and will be submitted into evidence for destruction.

All of the subjects at the gathering were advised to clean up the area and leave, at which time they complied. When the subjects left, units on scene made sure that no one leaving the gathering in a vehicle was driving under the influence. All subjects involved departed without incident.
