A delivery driver with Domino's Pizza reported a strong-arm robbery that occurred behind the Flagler Plaza Shopping Center with a 10-minute time delay. Units responded and set up a perimeter and K-9 Repo tracked to the parking lot where the track was lost indicating the suspect was no longer in the area on foot. Cash was taken from victim. 03-11-16/ 11:34 PM/ Zone 5 Robbery Person/ 16-22308/ State Road 100 E, Palm Coast. A store employee at Burger King reported an armed robbery where a male suspect forced her to the back room and made her give him all the money from the store safe. All units were on scene investigating the Domino's robbery (see above) and therefore were on scene at Burger King within seconds. A male was observed running from the parking lot, concealing his face with a hooded jacket. Cpl. Weaver took the subject, Victor Dove, into custody without incident. Dove claimed to be a store employee who was also a victim of the robbery and only fled due to having a warrant. A second male, also claiming to be a store employee, was also observed sitting on his bicycle in the parking lot. The male was determined to also be an employee of Burger King and was arrested and charged with robbery. See report by Deputy Wall for further.
