Subject 1 (S1) Michael Atkinson, S2 and S3 were located on the screened-in back patio with cannabis scattered across the patio table where they were seated. S1 attempted to flee after being handcuffed and a takedown was performed on him by Cpl. Weaver. S1 was charged with possession of cannabis under 20 grams, possession of drug paraphernalia, tamper with or destroy evidence, attempted escape and resisting arrest with violence. Charges were submitted to the State Attorney's Office for review on S2 and S3 for possession of cannabis under 20 grams. Response to resistance report completed and Cpl. Weaver was treated at FHF.
