### Non-Part One Crimes: Missing Persons, Traffic Fatality, Use of Force, Weapons

Stolen Vehicle Recovered/ 16-038389/ Wellington Drive and Weidner Place, Palm Coast. Originally reported as a single vehicle crash into the water way, it was determined there were no occupants inside and no sign of a driver. Upon running the vehicle information, it was discovered that the vehicle was reported stolen out of St Johns County( Case # SJSO16OFF004784). Vehicle was not processed due to being mostly submerged. See report by Deputy Casey for further.

Warrant Service/ 16-38447/ 3855 CR 304/ Units attempted to serve a felony arrest warrant on Joseph O'guin. A subject fitting the description of Joseph was seen walking towards the wood-line near the rear of the property (several hundred yards away). He ignored commands to stop and walked into the woods. Another resident of the property advise that subject was Joseph, phone contact was made with Joseph where he advised he was coming out to surrender but never did. A perimeter was established, fireflight was launched and K9 deployed. During the track K9 Kaos collapsed from heat exhaustion and had to be extracted and taken to Flagler Animal Hospital. Admin page was sent. Joseph was never located. There are no additional charges because deputies were not able to definitively say the subject seen walking into the woods was Joseph and heard their commands. Report by Dep Gonzalez.
