Attempted Aggravated Assault on LEO/2016-95248/ Carry Court, Palm Coast/ Zone 2/ Dep. Petkovsek responded to this location reference a court order violation and disturbance. S1 Jennifer Heidel had caused a scene at the residence. Upon arriving, Heidel was exiting in her vehicle when Dep. Petkovsek told her to shut down the vehicle and exit it. She then drove toward Dep. Petkovsek and struck his patrol vehicle intentionally. Deputy Petkovsek jumped onto the hood of his vehicle for safety. A pursuit was initiated and continued to the county line on State Road A1A north. St. Johns County deputies used stop sticks to stop the vehicle and arrested Heidel. She is charged with Flagler and St. Johns county charges.
