Units responded to an annonymous call of a possible disturbance. Upon arrival, blood was observed on the ground in the area of the door. S1, stated the blood was her husbands and she caused it. V1, had a cut on his ear from where he was struck by a drinking glass thrown by S1. The argument stemmed from something S1 observed on his facebook page. S1 was arrested and charged with Domestic Battery. V1 refused treatment and did not wish to cooperate with our investigation.
