checking, the subject's vehicle was located at the hangar. The homemade plane was not in the hangar and it is believed he took flight in it. Subject has previous flying experience, but he had not yet flown this particular homemade plane. He apparently stated to his son that he was waiting for the weather to clear so he could test it out. Subject's phone was pinged numerous times with each ping hitting somewhere in the vicinity of his residence. It is believed he left his phone somewhere at the residence. Numerous calls via dispatch to Emergency Contact numbers for the airport were unsuccessful. VCSO Air One checked the area around the airport with no results. Teletype message sent statewide. FAA notified. Investigation continues.
