At approximately 03:36 what appears to be a Jeep type vehicle enters the parking lot and an unknown subject throws something flaming into the garbage can. A passerby later sees flames and calls 911 prompting an FCSO deputy and the PCFD to respond. The deputy used a fire extinguisher to combat the flames and prevent spread to the building itself until the PCFD arrived and extinguished the fire. No apparent damage to the building just the trash can.
