V1 also stated that during the incident she was trying to yell for help and S1 was covering her mouth to try to prevent anyone from hearing her. Law enforcement on scene could hear S1 holding V1 down within the residence as she was yelling for him to let go of her wrists and to let her go. Upon knocking on the front door, S1 tried to flee out the rear sliding glass door of the residence but he was detained. S1 was charged with felony battery with a prior conviction, false imprisonment, tampering with a victim and resisting arrest without violence.

10-06-14 @ 0250hrs / Zone 6 / Domestic Disturbance / 14-91107 /Lloshire Path, Palm Coast. Subject 1 grabbed his girlfriend around the neck and pushed her over a chair during an argument after coming home from Johnny D's. S1 was taken to jail for DV battery.
