Road patrol checked out with a DAV, which after further investigation turned into a physical disturbance. The female was transported to FHF with head, face and rib injuries. However, it was unable to be determined who the suspect was and where the incident occurred. After treatment at FHF the victim provided a taped statement and felony Domestic Violence charges were filed against the male who was in the vehicle. There was also a SJSO pretrial release that was obtained after the fact and charges were submitted on that as well. SJSO refused to go to the suspect residence and attempt an apprehension without an arrest warrant. There was no imminent danger to the victim and charges were submitted.
