The RP didn't answer the door and shortly after the front door was kicked in and two black males were at the entrance. One male was known to the RP as Darius Harvey 4/7/95 and the other known as "Mike Mike." These subjects fled the residence and were subsequently located on Commerce Boulevard. A showup was conducted; RP positively identified the second as Mack Jones 1/24/98. Both were arrested for Attempted Burglary to an Occupied Dwelling and Criminal Mischief.
