The female left the residence prior to law enforcement arrival. Attempts to locate her met with negative results. 3-25-16 at 12:26am / Zone 2 / Assault, Battery / 16-26580 / Palm Coast Parkway N.E., Palm Coast. S1 Daniel Garcia spat on Victim 1 (V1) during an argument. V1 declined pressing charges against S1. S1 provided law enforcement with multiple identities and while being served a trespassing warning at his residence (12 Renshaw Place), S1 became unruly with deputies. He was charged with resisting with violence, violation of injunction, battery on a law enforcement officer (kicked Deputy Colson) and giving a false name while detained. Deputy Colson was not injured. While being transported to FCIF, S1 became combative in Deputy Daniel Malta's patrol vehicle. S1 was then transported to FHF, via Rescue 92, treated and then transported to FCIF. S1 was also found to be on felony probation reference grand theft.
