Warrant Service/34364-16/Zone 2/ Crossbow Court, Palm Coast. D-1 Brandon Matthew Bradley W/M 6-19-85 was arrested on an active Putnam County warrant reference VOP (Uttering Forged Instruments). D-1 was also trespassed from the residence following an initial investigation of a disturbance at the residence.

Crash with Injuries/34449-16/Zone 2/ I-95 northbound @ Palm Coast Parkway exit. Black GMC Denali Z71 pickup pulling a 19-foot Starcraft boat was pulled over on I-95 northbound, just south of exit 289 due to a flat tire. Occupants of the Denali advised they were hit from behind, and observed a black SUV rolling over. The driver of the black SUV (no tag available) was ejected, and transported by FireFlight to Halifax. I-95 northbound was shut down temporarily while FireFlight loaded the patient. Fire Police established traffic control, and FHP took over the investigation (FHP Case #OFF014847).
