### Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Disturbance-Domestic/44924-16/ Roxboro Drive, Palm Coast. Disturbance between a man and his girlfriend. Both parties gave conflicting statements about the incident. The male left the residence to avoid further confrontation. Report made.

Crash w/injuries/44942-16/Belle Terre Pkwy north of S.R. 100, Palm Coast. Vehicle vs. motorcycle. A white male was lying on the ground with a shoulder injury. Belle Terre northbound by the entrance to Target was shut down until rescue could remove the male. FCSO Traffic Unit took over the investigation, and Fire Police established traffic control. Motorcyclist did not appear to have life-threatening injuries, but was transported to Halifax. One lane re-opened northbound at about 12:30pm on Belle Terre Parkway.
