Neighbors alerted the homeowner of the male snooping around on the property. Deputy C. Taylor located D-1 within the fence of the residence and beyond the posted No Trespass signs.

Criminal Mischief/45551-16/Zone 7/ Cody's Corner, State Road 11. A business owner called to report what appears to be a bullet hole in one of the windows. It appears that the bullet went through the glass window, through a jar of pickles, and through shelves inside the business. Attempts to locate the bullet met negative results. Night shift responded to a glass break alarm at approximately 2:45am earlier this date. The responding units noted the hole in the window but no contact was made with the emergency contact. Surveillance video shows a truck pull into the parking lot near the time of the alarm but the truck could not be identified.
