Narcotics arrest / 16-46029 / CR 305 near Country Cooler / Subject was arrested for driving with a suspended or revoked license (with knowledge), possession of cannibis under 20, resisting arrest, and possession of a firearm by a convicted felon. Baker Act / 16-46077 / Bunnell. Responded to this location due to a third-party potential report of a sexual offense. While enroute the reporting party went to the residence to check on the victim and confront the possible suspect. The reporting person confronted the suspect and at some point shots were fired at an unknown direction near the house. It was believed the victim and small child were still in the house with the suspect. PA announcements were made; the alleged subject and alleged victim exited the house without incident; the child was located inside
