Larceny-Shoplifting/54755-16/ Cypress Point Parkway (Walmart), Palm Coast. D-1 Samantha Brewer (w/f DOB 7-16-1988) was arrested for Aggravated Battery, Felony Retail Theft (2 or more prior convictions), and Resisting a Merchant.
