Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Larceny / 2016-59793 / Zone 3/ Ace Hardware. Reporting Person (RP) reported that on 7-2-2016 at approximately 7:01 p.m., an unknown suspect entered the store and purchased a bottle of orange soda. The male reportedly had \$200 in 1- and 5-dollar bills. The subject asked the clerk on duty if he could swap out the ones and fives for larger bills; the subject (apparently on purpose) intentionally confused the clerk and stole \$100. Non-Part One Crimes: Missing Persons, Traffic Fatality, Use of Force, Weapons

Domestic Disturbance (Physical/ Use of Force)/ 2016-59802/ Karas Trail, Palm Coast. Units responded to a domestic disturbance and while attempting to detain the male suspect, Subject 1 (S1) John Podak, he resisted and pushed Deputy Priester into a wall while she was attempting to detain him. Sgt. Neat, Deputy Santoianni and Deputy Priester took S1 to the ground and took him into custody. S1's wife, S2 Jennifer Caulfield, attacked Deputy Santoianni, causing Deputy Gimbel to perform a takedown on the female. Both subjects charged with battery on law enforcement and resisting with violence. S1 also charged with domestic battery against a different adult relative. See report by Deputy Parker for further.

911 Investigation / 2016-59768 / Zone 2/ Blairsville Drive, Palm Coast. Corporal Goncalves responded in reference to a larceny. While on scene, RP was warned by Corporal Goncalves to not call and misuse the 911 line when there is no emergency. RP was instructed to call on the non-emergency number to contact the Sheriff's Office. Upon units leaving only a few minutes later, RP called 911 again to speak with a supervisor.
