### Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

S1 was taken into custody and was transported to the VCSO inmate facility by Deputy C. Taylor and was charged with grand theft (Motor Vehicle) and grand theft over \$300 (Items in vehicle). Larceny/ 64540-16/ Elder Street / Zone 7 / V1 advised he brought a friend to his residence. After the friend left, V1 noticed his firearm was missing. V-1 also stated that he noticed his prescription medication was missing from his vehicle. The firearm was entered into state and national databases as stolen. Robbery-Home Invasion /64610-16/Watermill Place, Palm Coast. / Zone 4/ A home invasion robbery was reported. No injuries. Further investigation pending. See report.

Stolen Vehicle-Recovered/64616-16/Palm Harbor Parkway, Palm Coast. / Zone 2/ A 2007 Ford F-150 was recovered at this location and found to have been reported stolen out of Broward County.

Disturbance-Domestic/64631-16/Pebblestone Lane, Palm Coast. / Zone 4/ A verbal disturbance occurred between V-1 and her husband, Defendant 1 (D-1) Shawn R. Higgins (w/m DOB 12-9-66). A check revealed D-1 was in violation of a valid injunction for protection against domestic violence (V-1 is the respondent). D-1 was arrested and transported to the Flagler County jail for processing without incident.

Disturbance-Domestic/64629-16/Ricker Place, Palm Coast. / Zone 4 / V1 reported he and his girlfriend, S1 Jane Gustin, were involved in a physical altercation. She then left the residence and later returned and discovered she was locked out. She broke a window to get in, lacerating her right hand. S1 then slapped V1, leaving red marks and blood on him from her laceration. S1 was transported to FHF by ambulance and later arrested for domestic battery (dating violence).
