Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Stolen Vehicle/ 16-68048/ Oak View Circle, Palm Coast. Victim 1 (V1) reported that her vehicle was stolen from her garage while she was out of town. The vehicle was taken during the course of a burglary committed at the home. The vehicle was later recovered by VCSO and was removed from state and national databases. A suspect was located within the vehicle and was arrested on multiple Volusia County warrants (Quentin Jones, b/m, 10/10/99). Report by Deputy Casey.
