Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Disturbance-Domestic/59843-16/Zone 4/ Prospect Lane, Palm Coast. Units responded in reference to a disturbance involving Victim 1 (V-1) and Defendant 1 (D-1) Randy Blyth. The investigation revealed that D-1 had assaulted and battered V-1. When units attempted to arrest D-1, he became combative, pushing multiple deputies and resisting all efforts to detain him. D-1 was subsequently restrained and placed under arrest. D-1 was charged with Domestic Battery, Domestic Assault, Battery on Law Enforcement x3, Resisting Arrest with Violence, and Tampering with a Victim. Reports made and appropriate forms completed.

D-1 Wendell Truman Hill W/M 11-18-77 was arrested for DUI crash with property damage after he rear-ended a truck at the intersection of Belle Terre and State Road 100. D-1 then backed up and struck a second vehicle that was stopped behind him at the light. D-1 drove around the first vehicle he struck and fled to the Publix parking lot. He was then apprehended in the parking lot by the occupants of the vehicles he struck. D-1 was additionally charged with possession of marijuana, hashish, and drug paraphernalia.
