Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Burglary Residential/77985-16/ Windward Drive, Beverly Beach / Zone 1 / A reporting person (RP) reported a delayed burglary from a week ago. A neighbor found her door open and resecured it. The RP came to check on the residence; she found that a TV valued at \$170 and two ceramic roosters valued at \$50 each were stolen from the residence. No signs of forced entry to the residence. Report made.

Burglary-Attempt/77998-16/ Citation Boulevard, Palm Coast / Zone 6 / RP reported that he saw two males near the fence of the property. The two males fled when they noticed the RP. A section of the fence was found to be cut and a pillow case was found near the fence. The suspects were not located. Report made.

Stabbing/78068-16/ Felshire Lane, Palm Coast /Zone 2/ RP advised he was stabbed in the back with a large knife by a friend. Prior to units' arrival, the suspect was stabbed and jumped into the swimming pool. Both parties provided limited information on scene due to the extent of injuries, and both were transported to Halifax by ground. ISD was notified and responded. Call still active.
