Sex Offense/80934-16/Florida Hospital Flagler, 60 Memorial Medical Parkway, Palm Coast. / Zone 5/ A female victim advised that she was accosted by an unknown black male at a motel in Daytona Beach and then transported to Palm Coast and again sexually assaulted. The victim at some point feigned an illness and the suspect transported her to FHF. The victim reported the assault to the nurses on duty and the suspect left the hospital. Preliminary report by Dep. Laverne. Investigation turned over to detectives.

Burglary-Residential/81032-16/ Pine Lake Parkway, Palm Coast / Zone 3/ V-1 and V-2 reported that between 10:00am and 1:30 pm on this date, an unknown person(s) entered their residence and stole several items. No signs of forced entry. Victims stated they may have left the door unlocked. The residence was processed.
