9-1-15 at 12:59pm/ Zone 5/ Burglary of Occupied Dwelling (just occurred)/ 15-90178/ Bulow Woods Circle, Palm Coast. Victim saw subjects attempting to force entry into the home who he then scared off by yelling at them. They fled. Victim provided a description of two white males occupying a white Kia. Deputy Breckwoltd located the vehicle traveling on John Anderson Parkway, conducted a traffic stop and secured three (3) suspects without incident. Dep Breckwoltd identified them as S1, Bradley Douglas Pyles; S2, Shawn V. Olique, and S3, Courtney Nicole Bryant). The white Kia was entered stolen out of Kentucky. Dep Breckwoltd obtained post-Miranda admissions form Pyles and Olique. Crime Scene Investigations responded. Detectives from the Investigative Services Division conducted additional interviews with the suspects and they admitted to several burglaries in other jurisdictions. Pyles and Olique were arrested for Burglary of an Occupied Dwelling and Grand Theft Auto.
