9-14-15 at 9:16pm / Zone 6 / Disturbance Domestic / 15-95120 / Remington Road, Palm Coast. Gregory Smith was arrested for domestic battery by strangulation after throwing his wife to the ground and attempting to choke her with both hands.

9-15-15 at 2:23am / Zone 3 / Disturbance Domestic / 15-95177 / Bradmore Lane, Palm Coast. A victim reported being struck across the head by S1 (Charlene Rawlings) with a vase. Upon arrival at the residence, S1, along with several other family members, refused to open the door to speak with deputies. After making several requests for the subjects to exit the residence, entry was made thru an open door at the rear of the residence. All occupants were secured without incident and escorted out of the residence. Once outside, S1 was identified and arrested for aggravated domestic battery as well as resisting without violence. S2 (Wiston Rawlings) was also arrested for resisting without violence. S1 was transported to FHF due to pre-existing medical issues and S2 was transported to FCIF without incident. At his request, V1 was transported to the Men's DV Shelter in Daytona Beach.
