Reporting person stated that a juvenile male was looking for a friend's residence and accidentally knocked on the wrong door. The juvenile stated that he left the residence and two adult females, identified as S1) Cadance A. McCall and S2) Letitia C. Crimes, exited the residence and confronted him and several other juvenile males at a pond where they were fishing. The juveniles stated that S1 and S2 pointed guns at them and threatened them not to come back to their residence. The juveniles then ran to their residence and S1 and S2 followed them, and knocked on their door still in possession of the handguns. Upon arrival, both suspects were in the parking lot in possession of semi-automatic handguns. S1 and S2 were arrested and transported to the jail for possession of concealed weapon and aggravated assault with a deadly weapon.
