Victim displayed signs of injury (bruising under right eye, left arm, and shoulder area). D-1 admitted to battering the victim because she was yelling. D-1 was then taken into custody without incident.

9-2-2015/6:11P/ Zone 7/ Disturbance Domestic/ 90706-15/ Fruitwood, Daytona North. Verbal altercation occurred between grandmother and granddaughter at the residence. Both parties claimed they were hit by the other, yet neither subject had any marks or signs of injury. Due to inconsistent information and not being able to determine if a crime actually took place, no arrests were made. Parties were separated for the night.

9-2-2015/ 10:41P/ Zone 5/ Baker Act/ 90799-15/ Slowdrift Turn, Palm Coast. Female subject made multiple harassing phone calls to FCSO dispatch via 911 and non-emergency lines starting around 5pm after her husband was arrested for DV Battery. Upon deputies' arrival, she was sitting on the back porch of her house on the phone with 911 yelling and cursing at 911 operators. She kept saying she needed help, then became belligerent, making numerous threats to kill (shoot) Law Enforcement and then made comments that she was going to kill herself. She was secured and transported to Halifax hospital without Incident. Charges will be forwarded ref misuse / abuse 911 system.
