It was later determined that a female was lying on a couch bleeding from several locations. Upon entry into the home, a third person was also found in the living room with subject 2. Subject had several cuts and bruises but was incoherent to the point where she could not provide a statement about the incident at this time. The man stated she fell in the house due to her level of intoxication, which caused the injuries. At this time it is undetermined if a crime has occurred but the incident was suspicious. A follow-up will be conducted to obtain a statement from the woman later. ISD was notified.
