A couple V1 and V2 had their Nissan truck blocked in at the intersection of Riviera Drive and Rickenbacker Drive by S1 (Joshua Rosa) and S1's wife, S2 (Tabitha Rosa). V1 attempted to get away from S1 and S2, however, S2 followed V1 and began ramming his truck from behind. A witness was in his garage near the intersection and witnessed the entire incident and provided the same version of events as V1 and V2. Skid marks and evidence on the scene also corroborated V1 and V2's statements. S1 and S2 were arrested.
