Suicide/ 16-73631/ Llanes Place, Palm Coast. A woman reported that her daughter just shot herself. Upon arrival, units found the daughter with a single gunshot wound to the head. She was pronounced deceased by Flagler County Rescue. Investigation turned over to the Criminal Investigations Division. Report by Deputy Myers.

Disturbance-Domestic/ 16-73671/ Palmyra Lane, Palm Coast. A female hit her boyfriend in the back during an argument. Neither party would cooperate with a criminal investigation and parties were separated for the evening. No injuries were apparent or reported. Report by Deputy Gonzalez.

Disturbance Domestic/ 16-73703/ Smyrna Court, Palm Coast. A verbal disturbance was reported by a female, who stated that she was involved in a verbal altercation with her boyfriend, S1. While on scene, deputies noticed minor physical injuries to V1, who refused to provide a statement or allow herself to be photographed. Charges were completed on S1, who was not on scene. Attempts will be made by day shift to locate and arrest S1. Case report held pending results of these attempts. This case will be finalized this evening. Report by Deputy Myers.
