Part One UCR Crimes: Date / Time / Zone / Type of Call / Case Number / Address / Case Summary

9-18-15/ 3:59pm/ Zone 6/Larceny (Grand) and Petit/ 15-96367 and 15-96383/ 5100 SR 100 E (Target) and Winn Dixie, Palm Coast. S1 (Calvin Burnham b/m 7/29/61) and S2 (Calvin Burnham Jr b/m 11/17/82) entered Target and stole 3 bottles of cologne then fled. Loss Prevention provided the direction of travel and vehicle description. A deputy located the vehicle and conducted a stop. The subjects attempted to flee but were initially blocked by traffic and then blocked in by Sgt Williams. Several more bottles of cologne were in plain view and are believed to have been stolen from another store. Also in plain view in the vehicle was over \$300 of meat. Under 20 grams of marijuana was also located in the vehicle. The investigation revealed the meat was stolen from Winn Dixie a short time earlier. S2 also had an active warrant for TA for grand theft and uttering forged checks. S1 arrested for 2 counts retail theft (1 felony, 1 misdemeanor), and resisting without violence, VOP, DWLS, and possession under 20 grams. S2 was arrested on the outstanding warrant and also charged with retail theft (1 felony count, and 1 misdemeanor count.
