An investigation revealed that she was angry with him because he would not help her pay rent. While he was trying to sleep, she put a leg lock around his neck. Patricia Jordan was arrested and transported to the FCIF. He was offered victims rights pamphlets and standard DV paperwork.

10-19-15/6:59pm/Zone 3/Larceny/2015-106955/ Palm Coast Parkway, Palm Coast. RP reported that her two children had ridden their bicycles to the library and while they were inside, the bicycles were stolen. An investigation revealed that Raymond Glass was in possession of one of the bicycles a short while later riding in the area. While Glass was detained, he kicked Deputy Petkovsek; however, caused no injury. Glass was arrested and the bicycle was turned over to the victim. Glass later threatened to kill a corrections officer once he arrived at the facility.
