About a week ago we were approached by a couple that was interested in renting one of the units we manage to open a Bottle Club. After doing some research about Bottle Clubs and the type of clientele they typically attract we did not want this type of business in the shopping plaza.

As a business person, having an establishment where one can consume alcoholic beverages anytime during the day or night is not what we need in Palm Coast. This would affect owners/tenants of other businesses that may be in the same vicinity of a Bottle Club. There could be a good possibility that owners of shopping centers/plazas might see a larger vacancy rate if a Bottle Club would be allowed to open in their center/plaza.

I would support a law that would not allow a Bottle Club to open within the city limits. I would support a law that would not allow a Bottle Club to open within Flagler County. Just this past year there was a murder at a Bottle Club in Volusia County, we do not need that type of activity in our back yard.

I was disappointed to hear that a "bottle club" would potentially be allowed in a center that is zoned COM2. With this e-mail I am respectfully requesting that the planning department and the city commission please review these type ordinances in hopes of protecting businesses such as ours from being subjected to the types of things that go on in businesses such as "bottle clubs". If you look at the history of "bottle clubs" you will see that the Police classify these types of businesses as a "nuisance" where they are often called to break up fights and investigate murders that happen on site..... As a business owner I have a fiduciary responsibility to protect not only my guests, but my employees as well. I do not take this responsibility lightly, and again I ask that the type of zoning be reviewed for us to help protect the "family type atmosphere" our center and for that matter protect the city of Palm Coast of the "family friendly-safe atmosphere we have built for so many years.

Dear Mayor Netts and Members of Palm Coast City Council:

I recently learned that a bottle club is trying to locate in City Marketplace in Palm Coast. I am a member of the Flagler County Art League and a frequent customer at both Cut Up and Sew and Dominic's Deli - all located in City Marketplace. Both the Art League and Cut Up and Sew have evening events that I often attend.

Bottle clubs in other cities have been associated with an increase in crime and disturbances in the surrounding area. Patrons are allowed to carry in their own liquor and drink after other bars close. Altercations frequently spill over into the parking lot. Traffic in illegal drugs is also associated with bottle clubs.

I am very concerned for my personal safety as well as the safety of other women, particularly in the evenings after dark, should such an establishment be allowed in the area. Further, I fear that this will harm the valuable businesses in City Marketplace. Security in the businesses is at risk, and customer base will likely decline if crime rises in the complex. City Marketplace has had difficulty during the recession and is on its way back, but introducing a business of questionable nature will not help future development.

I urge the city council to follow the path of other nearby cities such as Daytona Beach and Ormond Beach and <u>ban bottle clubs from the city.</u> Please keep our town safe and a pleasant place to live. Further I would encourage Flagler County to pass a similar restriction for bottle clubs within the county limits.

We urge you to do all you can to prohibit this kind of establishment to move into Palm Coast.

We, along with many other of our peers, picked Palm Coast to live because of its excellent appearance, great services, and obvious pride in our community as shown by our terrific city employees and excellent planning.

Dear Honorable Mayor and City Council:

We are a well-established quilt and sewing shop located in the City Marketplace here in Palm Coast. As you likely know, many types of businesses are located throughout the City Marketplace, including a children's dance studio, Zumba dance studio, orthodontist, art league, restaurants, etc. Our business is mostly geared towards older women who spend many hours taking classes and sewing at our store, including during the evenings.

We were just informed today that a Bottle Club is attempting to lease a unit here in the City Marketplace and located just a few doors down from our store. Knowing the type of clientele that Bottle Clubs typically attract and the resulting disturbances, violence and crime that typically arise from such an establishment, we definitely do not want this type of business in the City Marketplace, or anywhere in Palm Coast or the surrounding areas for that matter.

Such an establishment places our customers and employees at serious risk. We cannot have our customers or employees feel insecure just by being at our store, with a Bottle Club located so nearby wherein people are consuming alcoholic beverages day and night. Should this Bottle Club be anything like the ones in Volusia County, it would likely evolve into illegal drug activity and related violence. We also cannot risk the high likelihood of crime being committed
