September 5, 2015 at approximately 3:37 PM I, Jacob West, responded to Ocean Shore BLVD. and North Fourth Street, in reference to an armed Robbery. The victim, David Adams, called Flagler County Communication personnel and stated he had been robbed at gun point. David advised Flagler County Communication personnel that the suspects were two white males; both had slim builds and were tall. David also stated to Flagler County Communication personnel the male with the firearm had a black hat and short brown hair and that the males fled south, one along the beach and the other along Ocean Shore BLVD.

Once I arrived in the area of Ocean Shore BLVD. and Highway 100, I began to canvass the area. I observed two white males walking southbound in the area of S. Ocean Shore BLVD. and S. Ninth Street. One of the white males had no shirt, a black hat, and short brown hair. I immediately exited my patrol vehicle and stated to the males "hey guys come here."

The male with the black hat and no shirt, who is now known to me as Dacotah Clarke, continued walking southbound while the other male, Colten Pisapia, turned around and started walking towards me. I again called out to Dacotah "hey come here." At this time Dacotah turned around and started walking towards me and Colten started walking away from me. Finally both males turned around a walked towards me.

At this time I identified myself and Deputy West with the Flagler County Sheriff's Office and I informed both Colten and Dacotah that they match the description of armed robbery suspects and at this time they are detained. I asked both Dacotah and Colten if they had any weapons on them which they both stated "no". Once Sgt. Blank, with the Flagler Beach Police Department, arrived on scene I asked Dacotah and Colten if I could pat them down for weapons, both subjects stated "no". At this time I informed them that I was not asking and would conducted a pat down for officer safety.

At this time Dacotah stated to me that he had a loaded 9mm magazine in his front right pocket. I told Dacotah "do not put your hands in your pockets, I will get the magazine. I retrieved a single stack magazine from Dacotah's front right pocket. The magazine belonged to a Sig Sauer handgun. At this time both subjects were placed in handcuffs while the investigation continued.

I placed Colten in the rear seat of my patrol vehicle and provided Colten with his Miranda Warning. Colten agreed to speak with me on the matter. Colten stated the following:

Colten stated he did not see a handgun at any time. Colten stated Dacotah contacted the victim via telephone, because Dacotah wanted to buy "weed" from the victim. Colten stated that the victim met them behind a building in the area of N. Fourth St.. Colten stated the victim told Dacotah to give him his money and they began to fight on the ground. Colten stated that Dakota was able to break free from the victim and Dacotah started running. Colten stated he saw Dacotah running and began running with him.

It should be noted that Colten's story was extremely inconsistent. Colten stated several times that he was not with Dacotah, but then would provide information about the incident that only someone with firsthand knowledge would know.

At this time Dacotah and Colten were placed on the west side of Ocean Shore BLVD. and Officer Bingham, with the Flagler Beach Police Department, conducted a show up with the victim. The victim positively identified both subjects at this time. Dacotah and Colten were placed under arrest at this time by Sgt. Blank.

I transported Colten to the Flagler Beach Police Department and turned Colten over to Officer Bingham. I also placed the loaded 9mm magazine in a manila envelope and gave it to Officer Bingham. My axon video is limited during this incident because I was having connectivity issues. The footage I was able to obtain will be uploaded to evidence.com in a timely manner. Nothing further to report at this time.
