PRESENT: Mayor Linda Provencher, Chair Jane Mealy, Vice-Chair Marshall Shupe, Commissioners Rick Belhumeur and Kim M. Carney, City Attorney D. Andrew Smith, III, City Manager Larry Newsom, and City Clerk Penny Overstreet.

ABSENT: Commissioner Joy McGrew.

- <u>CALL THE MEETING TO ORDER</u>: Chair Mealy called the meeting to order at 1:00 p.m. 1.
- PLEDGE TO THE FLAG: Mayor Provencher led the pledge to the flag. 2.
- 3. DISCUSSION AND REVIEW OF THE 2015 LEASE FOR AMENDMENTS TO THE 2016 LEASE WITH THE MONTESSORI SCHOOL: The Commission reviewed their concerns with the current contract and provided suggestions for amendments. Discussion included; identifying the specific building in an exhibit attached to the lease versus identifying by address alone. A security deposit, not increasing rent to the point where the building would be vacant, the city using the budgeted money and perform the needed maintenance and repairs to the building, specifically the fascia. The alterations the tenant has performed on the building. Including a better description of the tenant responsibilities regarding maintenance to interior. Attorney Smith advised tenant is responsible for interior repairs (with exception of HVAC) and lessor for exterior, correcting the typo in the reference to seventy-two hours to provide lessor new keys. An exhibit that documents the alterations to the building, and the tenant is to return to condition as was when originally leased. A checklist for tenant and lessors protection with photographs. An addendum for moisture and mold. Suggestion to permit the garden to a certain well described area and with size limitations with suggestion of maintenance. Attorney Smith suggested the lease should be only to the walls of the building and recommended the Commission formalize a process for using the grounds outside the building, not an exhibit to lease; it would be an exhibit to a letter. If you want details fine, then if not in compliance with the detail, a process for how that will come to fruition. Discussion of estimated cost to return building to pre-alteration condition of \$7,500. The Fire Inspection which noted safety concerns was discussed and included; the locks on the exit doors. Tenant was advised the law requires a one-step process to exit, no more than one lock in use, and hole not repaired by the A/C technician that is open to the attic. The tenant Kerri Huckabee responded to the comments from the Commission. Ms. Huckabee feels she has improved the building and the buildings condition was poor when she leased it. Ms. Huckabee reported her numerous request for new doors made to the former city manager. Ms. Huckabee reported that belly-dancing and yoga classes are still provided at the building. Ms. Huckabee reported she has to leave due to a family emergency and noted her interest in the rent amount; adding, if more than a few

hundred dollars she would have to find another location. The Commission discussed rent amount and possibility of substantial increase after repairs are made. Discussion turned to the maintenance on the building. City Manager Newsom reported the repairs to the building will be done with or without this tenant and are a priority, unless this Commission tells him different. There are upgrades that are needed and will be presented in the 2016/2017 budget. City Attorney Smith advised at this time, City Manager is seeking direction to send a letter to the tenant advising that current lease will not be renewed, beyond that first step is to determine rent, provide that information to the tenant, and if requesting a deposit advise tenant as well. The Commission reached a consensus to increase the rent 20% and require a deposit equal to first and last month's rent, and to remove the CPI adjustment clause from the lease. Chair Mealy opened public comments. Paul Eik provided comment. Chair Mealy closed public comments.

Attorney Smith reported there is no question the existing order awarded cost and fees to the city, but the appellate court remanded on the issue of cost and fees that were not awarded that the appellate court said should have been awarded. Assuming the appeal process is over, there is need to go back to trial court to get the trail court to enter an order that increases the amount of cost and fees due to the city. Attorney Smith reported he is working with another city on their sign code and has crafted provisions that effectively address the Town of Gilbert ruling, stating basically, the changes would be to regulations on election, real estate and construction signage. Attorney Smith reported he would put the document on a future agenda for the Commissions review and direction. City Manager Newson reported on the letters to Florida Department of Environmental Protection (FDEP) asking to leave in place the foundations for the Scenic Highway Wayfinding signage that was not installed. Theory is that removing the foundations will cause more harm to the dune system than leaving them in place. Mr. Newsom reported on the Emergency Operations Center (EOC) Training attended by senior staff. Mr. Newsom spoke of the procurement process to have vendors in place in the event of a disaster. Mr. Newsom reported he received a call from Stephen Harris regarding the missing link (Flagler Beach) of the trail system in Flagler County. Mr. Newsom reported he would advise further when information is obtained. Mr. Newsom reported the Building Official provided an estimate of around 100k to bring the S. Central foreclosure property in to a state of habitability. Discussion ensued and included the possibility of a reversionary clause in the deed requiring the property to be brought into code within a specified time frame. City Clerk Overstreet reported the Deputy Clerk has scheduled the organizational meeting of the Economic Development Task Force (EDTF); one of the members has withdrawn. Clerk Overstreet requested direction regarding filling the vacant seat. Clerk Overstreet reported two persons have made their interest in serving on the Committee know, Vern Shank and Eric Cooley. Clerk Overstreet inquired, does the Commission want her to advertise for the position or do they wish to appoint the position from the two applicants. Chair Mealy opened public comment. Vern Shank recommended Mr. Cooley for the vacant seat on the EDTF. Chair Mealy closed public comments. Motion by Commissioner Shupe to appoint Eric Cooley to the Economic Development Task Force. Commissioner Carney seconded the motion. The motion carried unanimously.

<u>BACKGROUND</u>: The City Commission approved the original contract with McMahan Construction Company for this project. The contract included an allowance of \$5,000 to repair the steelwork on the north clarifier. These repairs exceeded this allowance by \$1,059 due to unforeseen problems with existing steelwork. The Project schedule remains unchanged.

<u>BUDGETARY IMPACT</u>: The city budgeted \$266,000 for this project; total cost after the change order will be \$267,059. A budget amendment for \$1,059 will be needed from unrestricted utility fund balance.



BACKGROUND: As you may recall Mr. Bache has been in front of the Commission twice requesting a refund, he was denied on both occasions. His SFR Permit was submitted after the first tree ordinance was adopted, and before the amendment was made to not charge for trees within the footprint. Flagler Beach Code of Ordinance, Appendix "A" Land Development Regulations Article 8 – Administration and Enforcement Section 8.04.17 (2) states: Procedure: Any person appealing any decision of an administrative official shall make such appeal within thirty (30) days after rendition of the order, requirement, decision or determination appealed from in writing to the city commission and file the same, and ten (10) copies thereof, with supporting facts and data with the city clerk. This does not, however, restrict the filing of a request for a special exception or variance by any person at any time as provided for elsewhere in this article. Upon receipt of said appeal, the building official shall forthwith examine such appeal or request application and endorse his or her recommendation thereon together with all documents, plans, papers or other materials constituting the record upon which the action appealed was taken and transmit same to the city commission. At the hearing, any party may appear in person, or by agent or by attorney.

Mr. Bache and /or his builder missed that time period. Yes, two others appealed and were refunded but they met the requirements of the regulations regarding appeal. In response to the reference to one appeal/refund approved by parent of a Board Member, it was actually Don Deal's (PARB Chair) son. Mr. Deal filed a Form 8B Memorandum of Voting Conflict, abstaining from the vote. Compounding Mr. Bache's frustration is he spoke with current Planner Larry Tornio a few months back and was told it was Chad's interpretation. Mr. Torino was not aware of the previous more stringent ordinance that included trees in the footprint. (The ordinance was passed and amended in the time period Mr. Torino worked at the City of Palm Coast.) I spoke with Mr. Bache and explained that Larry worked here previously and was not aware of both ordinances he is just seeing the current. Mr. Bache implied he feels singled out. Mr. Bache claims hardship as he was in Virginia at the time his house was being built.

The basis for this request is that my clients have now discovered that they are the only property in the entire city for which this fine was imposed. Several other properties were excluded from the payment, including the parents of a planning board member.

Please consider this request for relief. The interpretation by Mr. Lingenfelter to require this payment for the removal of palm trees in the footprint of the home was a bit extreme and without merit. To allow this payment to stand when no other property owners have been required to comply is not proper and would appear to result in unfair enforcement of the powers of the city.

The applicant has been issued a building permit for a single-family dwelling unit with a detached garage on a 50 foot wide property. A driveway permit and tree removal permit were also granted in conjunction with the structures. The building permit was issued with a condition that a protective tree barrier be placed at the dripline of the existing oak trees and that 66 inches of palm trees and 24 inches of oak trees be relocated, replaced, or a payment of \$4,500 be paid in lieu of relocation or replacement must be made prior to a certificate of occupancy.

Pursuant to Section 2.06.09.(12), Tree and Vegetation Removal; Tree Protection., "Any person required to obtain a permit and who is adversely affected by a decision of any city official or employee in the enforcement or interpretation of this article, may appeal such decision to the Planning and Architectural Review Board, which, by a majority vote, may affirm, reverse, or modify the adverse decision, (the Planning and Architectural Review Board shall have the authority to grant minor variances of no more than twenty (20) percent of any building setback line where such variance will preserve a tree which otherwise may be required to be removed in the absence of such variance) and any decision of the Planning and Architectural Review Board may be appealed to the City Commission, who may consider the entire matter de novo, and

by a majority vote, may fix anew the condition for removal of trees or vegetation, or may affirm, reverse or modify any decision made by any city official or city board prior thereto. Notice of appeal shall be made in writing to the City Clerk within thirty (30) days of the decision being appealed from. Any decision of the City Commission is subject to review as provided by law.

The applicant is appealing the requirement issued by the City Planner to mitigate the 24 inches of oak trees by requesting that the Planning and Architectural Review Board grant a minor variance of two (2) foot to the required ten (10) foot detached accessory building setback line and allow the permitted garage to be eight (8) feet from the north property line and preserve two (2) 12 inch oak trees.

The single-family house is setback 5.22 feet from the north property line, where the required setback is five (5) feet.

Recommendation

Staff recommends that the Planning and Architectural Review Board grant the requested minor variance of two (2) foot to the required ten (10) foot detached accessory building setback line and allow the permitted garage to be eight (8) feet from the north property line and preserve two (2) 12 inch oak trees with the following conditions:

- A protective tree barrier be also placed at the dripline of the preserved two (2)
 12 inch oak trees during construction; and
- 2. If the preserved two (2) 12 inch oak trees do not survive one (1) year after the issuance of the certificate of occupancy or completion, then the tree or trees shall be replaced by the owner of the site with a suitable replacement tree described in Section 2.06.09.(11), Tree Replacement Requirements and Schedule.



BACKGROUND:

UPDATE: The applicant was not present at the May 3, 2016 PAR Board meeting. The PAR Board tabled the item to the June 7th agenda. The Board tabled due to questions about safety, due to deck size and questions about entertainment location. See attached email. Applicant: Joe Frascogna ,500 South Ocean Shore Boulevard, Flagler Beach, Florida 32136. The subject property is zoned GC General Commercial. The applicant is seeking approval of an Annual Outdoor Entertainment Permit to allow amplified and non-amplified events consisting of music, spoken word and/or other forms of entertainment. Section 4-167, Review of Permit Application states, the city commission, after receiving recommendation from the planning and architectural review (PAR) board, shall approve, approve with conditions, or deny a permit for outdoor entertainment activity based on any of the following grounds:

- (1) The activity would present an adverse impact to the health, safety or welfare of the applicant, participants, public employees or members of the public and/or fails to protect the city's environment.
- (2) The activity would unreasonably inconvenience the general public.
- (3) The proposed activity is prohibited by or inconsistent with the Flagler Beach Code of Ordinances or the Flagler Beach Comprehensive Plan.
- (4) The applicant cannot meet, or is unwilling to meet, all of the requirements of this article.
- (5) The activity is proposed for a site that does not have adequate parking to accommodate the activity.
- (6) The activity is proposed for a site that is inherently hazardous to the participants or the public.
- (7) The event would have an adverse effect, and would unreasonably infringe upon, the rights of property owners within two hundred (200) feet of the property line of the subject property.
- (8) The event would conflict with another proximate event or interfere with construction or maintenance work.
- (9) The information furnished in the application is not materially complete and accurate.
- (10) The applicant has violated a provision, restriction or condition of this article or an outdoor entertainment activity permit issued to the applicant within the past and has not presented competent substantial evidence that measures to prevent future violations will be implemented at the property.
- (11) The requirements identified by the city staff to ensure public health, safety and welfare have not been met.
- (12) The comments and/or recommendations of the planning and architectural review board have not been addressed.

- (13) The proposed event or activity is prohibited by federal, state, or local regulations.
- (14) Other issues in the public interest as identified by the city commission.
- (a) In making a determination to approve a permit the city commission may limit the type and number of temporary structures and the duration of the activity including the hours and the number of days of the activity conducted to minimize any adverse impact caused by the activity.
- (b) Upon receipt of an application for outdoor entertainment activity, the city clerk's office shall review the application within five (5) working days of receiving it to determine if it is complete, fees have been paid and if the proposed activity qualifies as an outdoor entertainment activity. If so determined, the city clerk's office shall mail via regular mail a notice to all real property owners located within two hundred (200) feet from the property line of the subject property which notice shall include: the address of the subject property, the nature of outdoor entertainment activity sought, and the date, time and location of the PAR board meeting at which the application will be heard for recommendation. In deciding its recommendation on the application, the PAR board shall consider those same grounds listed above for consideration by the city commission. The recommendation will be brought to the city commission for final decision at its next available commission meeting.







1.0 - Introduction

Under Section 322 of the Robert T. Stafford Disaster Relief and Emergency Assistance Act (Stafford Act) enacted under the Disaster Mitigation Act of 2000 (DMA2K), states and local governments are required to have a Federal Emergency Management Agency (FEMA)-approved hazard mitigation plan in order to be eligible for federal hazard mitigation funding. DMA2K requires communities to develop a plan that follows a planning process to identify risks and prioritize projects. Local plans must be updated and adopted by all participating jurisdictions every five years in order to remain eligible for funding. Developing a Local Mitigation Strategy (LMS) gives Flagler County and its municipalities the opportunity to determine what all-hazards mitigation actions need to be taken to minimize damage before the next disaster strikes.

Communities face a variety of hazards. A hazard is any event or condition with the potential to cause fatalities, injuries, property damage, infrastructure damage, agricultural loss, environmental damage, business interruption, or other structural and financial loss. Three types of hazards profiled within this plan include:

- Natural hazards- result from acts of nature, such as hurricanes, earthquakes, tornadoes, wildfires, animal disease outbreak, pandemics, or epidemics.
- *Technological hazards* result from accidents or the failures of systems and structures, such as hazardous materials spills or dam failures.
- Human-caused incidents- result from the intentional actions of an adversary, such as a threatened or actual chemical attack, biological attack, or cyber incident.

The Flagler County LMS focuses on the major hazards that could potentially affect Flagler County and all of the participating jurisdictions in this plan. By evaluating hazards, identifying vulnerabilities and proposing solutions to them, Flagler County will be able to more efficiently meet the needs of its constituents. Hazards fully profiled in this plan include:

- Erosion
- Drought
- Extreme heat
- Flooding
- Tornadoes

- Tropical cyclones
- Severe storms
- Coastal flooding
- Storm surge
- Wildfire

Additionally, there are several natural hazards, as well as technological and human-caused incidents, that while not profiled to the same extent as those above, have been evaluated, and identified to be researched and monitored further.

The concept and practice of hazard mitigation is defined by FEMA as "Any action taken to reduce or eliminate the long term risk to human life and property from hazards". While the threat from hazardous events may never be fully eliminated, by minimizing the impact of hazards upon our built environment, we can prevent such events from escalating into major disasters.

The purpose of the LMS is to establish an ongoing process that will make hazard mitigation part of the daily routine for the entire community. The LMS identifies hazards based on the history of their occurrences and lists goals, objectives, strategies, and actions that will reduce or eliminate long-term risk to life and property from these hazards. Hazard mitigation is most effective when based on an inclusive, comprehensive, long-term plan that is developed before a disaster occurs. It is widely accepted that the most effective mitigation measures are implemented at the local government level, where decisions on the regulation and control of development are ultimately made. Implementation of planned, pre-identified, and cost-effective mitigation measures not only helps reduce loss of life, destruction of property, and damage to the environment, but also aides in the decision making process during the recovery and reconstruction following a disaster.

The 2016 LMS has undergone major revisions from the previous version. In spring of 2014 Flagler County Emergency Management hired a full-time mitigation planner. This newly created position was the impetus that inspired a renewed and energetic approach by the county toward mitigation initiatives. Future updates to the plan will be conducted in conjunction with the LMS Working Group and will continue to be a foundation for mitigation projects and prioritization throughout county government, municipalities, and other organizations within the county.

June 1, 2016

In May we produced 16,942,000 gallons of drinking water. This amount was 708,000 gallons less than the amount we treated in April. Rainfall for the month of May was 6.90 inches. We used 3,400 Gallons at the plant and used 8,052 Gallons on irrigation. The fire department used 7,000 gallons. We lost approximately 200,000 gallons on main break at Marina Bay paving project.

We have routine duties that are performed every day on each of the shifts. Samples taken every hour to make sure we keep the chemistry of the water within the parameters for DEP. We regularly perform over 200 tests on the City water and raw water daily between the three shifts. We do routine plant maintenance. We mow the plant grounds. We take well samples and draw downs for St. Johns River Water Management, also keeping daily records for the monthly reports that are required to be turned into the Department of Environmental Protection Agency every month. We also do quarterly reports for DEP on disinfection byproducts. We have the mid night shift flush the trains with high pH permeate water. We do yearly TTHM and HAA5 tests.

DEP requires us to take 5 bacteriological samples from the distribution system monthly, according to our population. All samples passed on May 10th.

I have Dennis Walker perform weekly vehicle checks. He checks all the fluids such as Brake fluid, windshield wiper fluid, transmission fluid, and all the lights.

We cleaned both Degasifiers.

We installed new lights in our Utility Shed.

We troubleshooted problem with well 11 generator and found the FPL power was low on one leg of the three phase power.

We installed new box for the finished water meter. We installed new finished water meter. We connected the new finished meter to the control cabinet.

We collected our monthly bacteriological samples for DEP.

We worked on getting quotes on different projects.

We pumped out electrical pits throughout the plant grounds.

We collected our quarterly well samples for St Johns River Water Management District. We also collected our monthly well, generator meter readings. We submitted our quarterly well quality report to St Johns River Water Management District.

We had a pine tree collapse and damaged the power pole to the water plant. FPL installed a new pole.

We built new shelves in our supply room. We installed a new laundry sink in the shop.

We updated our SOP for bacteriological testing.

We installed a new cooling fan in chlorine analyzer cabinet.
