Subsequent to executing the search warrant, FDLE Inspector Brett Lycett and FDLE Special Agent Supervisor (SAS) Richard Ward met with Weeks in her office at the SOE and provided her a copy of the signed search warrant. During this meeting, SAS Ward read the search warrant to Weeks who, at the conclusion of SAS Ward's reading, advised that she understood the particulars of the search warrant, the areas the search warrant permitted to be searched which included her vehicle parked in the parking lot of the SOE, and the items that the search warrant permitted law enforcement to seize.

For information of the file, a copy of the search warrant read to Weeks was placed in the case file as Related Item 6.

While meeting with Weeks in her office, Inspector Lycett and SAS Ward learned that Weeks had a blue steel, Smith and Wesson .380 Body Guard automatic firearm, serial number ECF3314 concealed in her purse which was sitting on the floor of her office. At this time, the firearm was taken into temporary custody by Inspector Lycett, and Weeks was advised that the firearm would be returned to her at the conclusion of the search.

Subsequent to seizing the firearm, Inspector Lycett and SAS Ward conducted a search of Weeks' vehicle a silver in color, 2003 Mercury 4-door, VIN#

Hadeed said he was joined in that room by Commissioner Charles Ericksen, who as an alternate Board member, also was not authorized to count ballots. Hadeed said that he and Ericksen had a conversation. Hadeed related, as the Board was conducting business in the next room, he and Ericksen were not part of the business, and he expected his conversation was private. Hadeed stated he was giving legal advice to Ericksen as a Flagler County Commissioner and as one of his clients, and that their conversation was in the nature of an attorney-client, and it was private. Hadeed stated he had an expectation of privacy because he was in a different room than the one in which the Board was conducting business, he was not part of the ballot counting, he was not on notice that recording was taking place, he was providing legal advice, and he did not consent for it to be recorded. Hadeed related that there were no lights or other warnings displayed within the room he occupied, warning that a recording was underway.

McDonald related that he had requested Weeks provide him a copy of the conversation recorded between Attorney Hadeed and Commissioner Ericksen, and that Weeks emailed McDonald the recording. McDonald stated that he recalled observing Hadeed and Ericksen in conversation, but McDonald said he had no idea what the two were talking about.

McDonald advised that he still had the email Weeks forwarded him with the recorded conversation attached. McDonald agreed to forward Weeks' email to Lindley.

The audio recording of McDonald's was included in Related Item (INV-17).

Hadeed stated that in five or six prior election cycles, Weeks had brought a micro cassette recorder into the Board meetings and Weeks would announce she was recording. Hadeed stated that Weeks turned on and off the recorder as the Board went on and off the record. Hadeed said that at the beginning of the current election cycle, Weeks announced that she would no longer record meetings and the Board agreed. Hadeed stated that the Board did not

SPC Langdon removed 8 drives from the server and these drives were forensically imaged using a Talon Forensic Imager, a Tableau TD2 Forensic Imager and FTK 3.1 Imager. There was no apparent break to the recording and at about the 1 hour and 55 minute portion of the recording, there was a comment that the Board had recessed at about 11 a.m. and it was now 4:00 p.m., and the meeting was called to order. Near the 2 hour and 52 minute point on the recording, there was a comment that the next meeting would be August 25, 2014, and the statement that the time of adjournment was 4:56 p.m.

Part 2 of the recording included a comment that it was 8:05 a.m., when the meeting was called to order. After opening formalities, there was discussion of 848 absentee ballots to process.

The following is a synopsis of the interview of Holland and should not be considered a verbatim transcription. For exact details, refer to the recorded statement that was placed into the Related Items section of this case file (INV-46).

Holland had independent recollection of the telephone call. Holland stated he did not give his consent to be recorded. Holland stated he knew of no provision in Florida Law that would allow Weeks to record his conversation without consent.
