**SUBJECT:** Approval of Appointments to the Flagler County Planning and Development Board

**DATE OF MEETING:** September 21, 2015

OVERVIEW/SUMMARY: The Flagler County Planning and Development Board was established by Section 2.04.02 of the Flagler County Land Development Code to review and make recommendations to the Board of County Commissioners regarding development plans submitted under the County's Land Development Code. The Planning and Development Board consists of seven members, each serving three year terms, each preferably having experience or interest in the field of land use regulation and residing in certain areas of the County.

There are currently three vacancies on the Planning and Development Board. The positions were advertised in the *News-Tribune* on August 8, 2015 (Attachment 1) and on the County's website.

The first vacancy is for a member residing *West of US 1 and South of SR 100*. A request for reappointment has been received from Mr. Michael Boyd for this position (Attachment 2). Mr. Boyd has been a member of this board since 2009, attending 12 of the 13 meetings held over the last year. No additional applications were received for this vacancy. Mr. Boyd resides within unincorporated Flagler County.

The second vacancy is for a member residing *Between US 1 and the Intracoastal Waterway, North of SR 100*. A request for reappointment has been received from Mr. Robert Dickinson for this position (Attachment 3). Mr. Dickinson has been a member of this board since 2009, attending 10 of the 13 meetings held over the last year. Mr. Dickinson lives within the designated area but within the city limits of Palm Coast.

The final vacancy is for a member residing *Between US 1 and I-95, South of SR 100*. A request for reappointment has been received from Mr. Russell Reinke for this position (Attachment 4). Mr. Reinke has been a member of this board since 2009, attending all of the meetings held over the last year. Three other applications for this position have been received by Ms. Annette Burgess (Attachment 5), Ms. Kathleen Pounds (Attachment 6) and Mr. Arthur Barr (Attachment 9). All applicants live within the designated area. Ms. Burgess and Mr. Barr live within the city limits of Palm Coast. Mr. Reinke and Ms. Pounds live within unincorporated Flagler County.

All applicants are residents of Flagler County and registered voters. Should additional applications be received, they will be presented to the Commission prior to the meeting. Attached for your information is the attendance record (Attachment 7) and current membership roster (Attachment 8) of the Planning and Development Board for your review. All appointments will be for three-year terms.

Staff will be bringing back to the Commission an amendment to the resolution establishing the Planning and Development Board whereby members of this board must reside within unincorporated Flagler County.

Dear Flagler County Commissioners:

I am interested in serving on the Flagler County Planning & Development Board, and have submitted my application for your consideration. I wanted to take this opportunity to expand upon my previous experiences serving on boards and projects which I was involved in with the planning staff.

I have served on the Plantation Bay Community Association Board of Directors from 2007 – 2014 and served as Vice President and Secretary for one year each and President for the remaining 6 years. As a member of this all volunteer board, I had the responsibility to enforce the governing documents and architectural standards for our community. In addition, I worked with other board members in developing rules and modifications to existing governing documents as the community's needs and statutory requirements changed over time. Many of our governing documents were written in 1985 and of course since then architectural standards, residents' expectations, demographics and even the way people work have changed. It was important to recognize change is inevitable and to work with all stakeholders to make sure the community is sustainable going forward into the future. As President I provided direct guidance to our Architectural Review Committee to insure that standards were being maintained while working with applicants in a fair and balanced manner so that conflict was resolved in a positive way. This effort required seeking input from our professional staff and on rare occasion, even legal counsel to be sure that we could be somewhat flexible when it made good sense and reach a compromise while following our governing documents.

In 2004 I was very involved with the NOPC (Notice of Proposed Change) to the Development Order for Plantation Bay and worked very closely with Walter Fufidio and his staff due to my support for approval of the NOPC. This application was the result of statutory requirements and changes, as well as proposed development changes to better position the community to be both attractive and competitive going forward. For whatever reason, this application faced quite a bit of opposition, and my meetings with Walter helped many supportive residents to understand the contents of the documents and the associated benefits for the community. The application was ultimately approved. I have met with Adam Mengel concerning easement issues between the Association and other entities within Plantation Bay. In addition, I was involved with and attended a meeting with staff regarding the text amendment to the code which permitted LED signs in gated subdivisions under certain criteria. As a personal research project I have been working on understanding how the Comprehensive Development Plan came about and over the last couple of months have been reviewing all documentation related to the Plan which the Planning Staff provided me.
