

Upon contact at the residence the defendant identified as Bert K. Knight confirmed he was the only occupant of the residence and advised he was the sole owner and operator of the computer.

A preliminary forensics exam was performed at the residence and several notable child pornography images were observed. The images were confirmed child pornography due to previous law enforcement investigations. The follow is a summary and descriptions of known child pornography files located on the computer in possession of Bert Knight during the preliminary exam;

- 2) File 3Y75TD6UKJ3YJPBAPOE6Z6CYX3XTZDQ3 : Video (approximately one minute long) depicting a young nude female (approximately 4-6 years old) sleeping as an adult male digitally penetrates her vagina and penetrates her vagina with his penis ejaculating on her vagina.
- 3) File 4AN5IOBCXOJVQDQUYQXBVZAUD2DM4NKL: Image depicting three prepubescent males naked on a bed, one male is performing oral sex on another and fondling himself.
- 4) File 5KDMIDEHYX3A6M7MNVLZF6QEG4ZF6ASE: Image depicting a nude female approximately 7-9 years old performing oral sex on an adult males penis.
- 5) File 7LNUSPG5VANQN7T5YE2NMZBU7BAWDGSQL Image depicts two prepubescent males (approximately 7-10 years old) with one male performing oral sex on the other male.
- 6) File AHXX3YYYVLZFI4LIM5Q6RFKD3E35Z7X4 Two separate images as follows; one image depicts a prepubescent nude female (approximately 7-10 years old) sitting on top of an adult male as he penetrates her vagina with his penis, the other image depicts a prepubescent female (approximately 7-10 years old) being forcefully penetrated by an adult female wearing what appears to be an artificial penis device.
- 7) File CYOA35VRDJRLUYLLNFUNKHCQZNGCSKXZ : Image depicts a prepubescent female (approximately 6-8 years old) being vaginally penetrated by an adult male's penis.
- 8) EDZAXANMCMF3U74NGEATUVJX37YCU2VK: Image depicts a prepubescent nude female (approximately 7-9 years old) performing oral sex on a young males penis.
- 9) GISLF553PNMP3FOBG4ZQ4PEPFAU4QU7E: Image of a prepubescent nude female (approximately 5-7 years old) performing oral sex on an adult male's penis.
- 10) HDDL7E5NRTO6C4GLBC4PC4MS4I3ECWOB: Image depicting a prepubescent nude female (approximately 3-6 years old) being vaginally penetrated by an adult male's penis.
