COUNT 1: 316.192 (3)(C)2 - RECKLESS DRIVING - SERIOUS BODILY INJURY

COUNT 2: 784.045 - AGGRAVATED BATTERY (DEADLY WEAPON/ BODILY HARM) (Lesser of

Aggravated Assault)

COUNT 3: 782.071 1(A) - VEHICULAR HOMICIDE (DIRECT)

R.J. LARIZZA, State Attorney for the Seventh Judicial Circuit of the State of Florida and as such prosecuting attorney for this Court, in the name of and by the authority of the State of Florida charges that:

COUNT 1: On or about February 9, 2025, in the County of FLAGLER and State of Florida, LEIGHA CATHERINE MAREI MUMBY did drive a vehicle in willful or wanton disregard for the safety of persons or property or did flee from a law enforcement officer in a motor vehicle, contrary to Florida Statute 316.192, and LEIGHA CATHERINE MARIE MUMBY did, by reason of such operation, cause serious bodily injury to DANIEL WATERMAN, contrary to Florida Statute 316.192(1) and 316.192(3)(a),(b),(c)2. (3 DEG FELONY) (LEVEL 1),

COUNT 2: On or about February 9, 2025, in the County of FLAGLER and State of Florida, LEIGHA CATHERINE MARIE MUMBY did actually and intentionally touch or strike DANIEL WATERMAN against the will of DANIEL WATERMAN, and in doing so used a vehicle, a deadly weapon, and/or in doing so intentionally or knowingly caused great bodily harm, permanent disability, or permanent disfigurement to DANIEL WATERMAN, and/or did intentionally or unlawfully threaten by word or act to do violence to the person of DANIEL WATERMAN, coupled with an apparent ability to do so, by purposefully driving her vehicle off the roadway towards the treeline, which created a well founded fear in DANIEL WATERMAN that such violence was imminent, and in doing so LEIGHA CATHERINE MARIE MUMBY did commit the assault with a motor vehicle, a deadly weapon; contrary to Florida Statute 784.045(2) and 784.045(1)(a) and 784.021(1)(a).
