The undersigned certifies and swears that there is probable cause to believe the above named defendant, on the <b>16th</b> day of <b>October</b> , <b>2018</b> , at approximately <b>0130</b> <input checked="" type="checkbox"/> a.m. <input type="checkbox"/> p.m. at <b>50 White Star</b> within <b>Flagler County</b> , violated the law and did then and there:					
On October 16 <sup>th</sup> , 2018 Princess Nioka Troi Williams did travel to the area of 50 Whitestar Drive with the intention of committing a robbery during a planned narcotics deal. Princess Nioka Troi Williams did possess a semi automatic handgun during the robbery and shot the victim, Carl Saint-Felix, in the back of the neck. Witnesses present during the robbery indicated Princess Nioka Troi Williams did plan the narcotics robbery ahead of time and went to the location without the proper funds to purchase the marijuana that was requested. Witnesses advised that Princess Nioka Troi Williams unlawfully entered the vehicle of Carl Saint Felix, in order to rob him of his cannabis and/or money.					
On 10/17/2018, Princess Nioka Troi Williams did voluntarily respond to the Daytona Beach Police Department, requesting to speak with Corporal Hristakopoulos. Corporal Hristakopoulos and Detective Quintieri did make contact with Princess Nioka Troi Williams, and she advised that she wanted to speak with them voluntarily. During a voluntary consensual interview (audio and video recorded) Princess Nioka Troi Williams did admit to bringing a firearm to what she knew to be a robbery, unlawfully enter the vehicle in question, and unlawfully shoot the victim in the back of the neck.
