the victim after being instructed to cease communication. Jerome additionally followed the victim while the victim was driving to a different location in town. Jerome also threatened to hurt the victim multiple times if she did not respond to him. Further, on November 17, 2022, Jerome was served with an injunction with the protected party being the victim of this case. On November 20, 2022, Jerome was charged with violating the injunction after he allegedly traveled to the victim's residence and initiated third party contact after the injunction was served. The victim also advised that approximately during the month of June 2022 that Jerome had attempted to solicit sex acts from her via text message. Jerome also routinely provided the victim with marijuana and alcoholic beverages. It should be noted that Jerome was aware of the victim's age at the time of the incidents.

During the course of the investigation, numerous admissions of guilt were obtained from Jerome in reference to soliciting the unlawful sex acts, contributing to the delinquency of a minor and stalking.

Jerome's actions serve no legitimate purpose and his actions have caused the victim to flee their home and stay at a different residence out of the area.
