OfficerID: rossi, Narrative

On 05/27/2015 at 12:35Hrs, I was dispatched to 2 Utility Drive (City of Palm Coast - Utility Dept.), Palm Coast, FL 32137, in reference to harassing telephone calls.

Upon my arrival I made contact with customer service manager Cynthia Schweers. Cynthia stated that a Palm Coast resident named Lorenzo Fields has been continuously calling and harassing the utility department. He has been harassing representatives being vulgar and making threats. Apparently a water line had ruptured underneath Mr. Fields' residence while he was away some months ago. This caused damage to his residence and a large amount of water was lost. This incurred a large water bill which Cynthia stated was past the water meter in the ground. The resident owns anything past the meter on the property. Mr. Fields demanded the City compensate him for the large water bill. Cynthia stated the City was able to lower the bill but an amount over \$200 remained. As he refused to pay for the water bill the meter was turned off. The water meters for 4 Bay Road and 28 Magnolia Road are in the same spot on the property of 4 Bay Road. Mr. Fields has intentionally parked his truck on top of both meters and prevented access to them.

On 05/26/2015, Mr. Fields called the Flagler County administrator's office upset over the water bill. He told Christie Mayer that he had parked his car over the meter and would continue to do so. He further stated he was going to dump a load of gravel over the meter so the City could not read it. He stated he had not had water in 3 months. In a later conversation he stated, "Someone is going to get hurt soon."

I obtained a sworn written statement from City of Palm Coast employee Alyssa Roscoe. Alyssa stated that Mr. Fields called the Utilities Department multiple times that she had answered. Mr. Fields has cursed and used foul language toward her on multiple occasions including yesterday and today. Yesterday (05/26/2015), called Mrs. Schweers a "cunt." Today Mr. Fields stated he believed the employees were told to intentionally hang up on him. He then told Alyssa to ask Cynthia "How many dicks she had to suck to get her job."

I further obtained a sworn written statement from City of Palm Coast employee Carol Shapiro who stated she picked up the phone today. The caller was Mr. Fields to advised Carol to tell Mr. Adams to "suck his penis" and then hung up the phone.

While I was collecting information at the Utility Department I was notified Mr. Fields had arrived at the City of Palm Coast main office (160 Cypress Point Parkway). Corporal Allen and Senior Commander Carman responded to this location and made contact with Mr. Fields. Mrs. Schweers also responded and talked with Mr. Fields as they attempted to reason with him. Mr. Fields was warned by Corporal Allen to cease the harassing communications with the City of Palm Coast.

I responded to 4 Bay Drive and stood by at the neighbor's residence. A City of Palm Coast employee responded and was able to access both meters as Mr. Fields was not there. The meter was normal and had not been tampered with. Mr. Fields was warned by Corporal Allen to cease the harassing communications with the City of Palm Coast.
