On 02/11/16 at approximately 1531 hours, I (DS Wood) responded to 25 Collingwood Ln, Palm Coast, FL, 32137, in reference to a report of a disturbance with weapons. Upon arrival contact was made with the Bryan Streetman, who stated that on 02/11/16 at approximately 1525 hours, he was operating his federally registered drone along the seawall at the rear of his residence, over the canal, and at times over others property, when his neighbor, Philip Lowe came out to his backyard at 29 Collingwood Ln with what appeared to be an unknown type gun and stated something to Bryan. Bryan stated that he only heard the word "shoot" and did not know if Philip stated he was going to shoot him or the drone. Bryan further stated that Philip never pointed the gun at him or in his direction. Bryan believed that Philip was upset due to what he considered him harassing the birds that were on his property.

Contact was made with Philip at 29 Collingwood Ln who stated that Bryan was harassing the federally protected migratory birds, Purple Martins, stating Bryan had told him they were "messaging up" his property. Philip was upset due to feeling Bryan was attempting to scare the birds away. Philip alleged that Bryan had a sound making device to scare the birds that code enforcement made him discontinue using and that he was pointing a laser at them. In addition Philip believed he was attempting to harass the birds by flying the drone in the area. Bryan stated that he said he would shoot the drone down and never pointed what was determined to be a pellet gun in the direction of Bryan.

Contact was made with Fish and Wildlife Commission (FWC) Officer Eric Meade who stated that the birds were federally protected from being taken/hunted. FWC Officer Meade stated that if Bryan was chasing the birds with the drone intentionally it may be considered harassment of the birds, but it would have to be witnessed and there would need to be established intent to harass.

Bryan was given a verbal warning in regard to flying the drone in the area of the birds and potentially harassing them. Philip was given a verbal warning in regard to brandishing something that may be mistaken for a firearm.

Both parties advised that the issues between them was ongoing and had been happening over a period of a couple years.

Bryan and Philip were both provided case information cards and advised to contact law enforcement with future issues to avoid potential criminal charges.

There were no crimes that were determined to have occurred; no probable cause existed for criminal charges against either party involved.
