**COUNT 1: LEWD OR LASCIVIOUS BATTERY,**

in violation of § 800.04(4), Florida Statutes, a Second-Degree Felony (LEVEL 8).

**COUNT 2: TRAVELEING TO MEET A MINOR,**

in violation of § 847.0135(4), Florida Statutes, a Second-Degree Felony (LEVEL 7).

**IN THE NAME AND BY THE AUTHORITY OF THE STATE OF FLORIDA:**

**COUNT 1: LEWD OR LASCIVIOUS BATTERY**

NICHOLAS B. COX, Statewide Prosecutor for the State of Florida, by and through the undersigned Designated Assistant Statewide Prosecutor, under oath, charges that beginning on or about May 31, 2024, and continuing through and including June 1, 2024, in the Seventh Judicial Circuit of the State of Florida, to wit: Flagler County, Florida, the Defendant, **JORDAN SCOTT PITTMON**, did unlawfully engage in sexual activity with M.V., a person 12 years of age or older, but less than 16 years of age, by the penetration of or union with the female genitals of M.V. by the sexual organ of Jordan Scott Pittmon or any other object, contrary to Section 800.04(4), Florida Statutes, against the peace and dignity of the State of Florida.

**COUNT 2: TRAVELING TO MEET A MINOR TO DO UNLAWFUL ACTS**

NICHOLAS B. COX, Statewide Prosecutor for the State of Florida, by and through the undersigned Designated Assistant Statewide Prosecutor, under oath, charges that on various dates beginning or about October 28, 2023, and continuing through and including June 1, 2024, in the Seventh Judicial Circuit of the State of Florida, to wit: Flagler County, Florida, the Defendant, **JORDAN SCOTT PITTMON**, did travel any distance within this state, for the purpose of engaging in any illegal act described in chapter 794, chapter 800, or chapter 827, or to otherwise engage in any unlawful sexual conduct with a child, to wit: M.V., after using a computer online service, internet service, local bulletin board service, or any other device capable of electronic data storage or transmission to seduce, solicit, lure, or entice, or attempt to seduce, solicit, lure, or entice M.V., a child, to engage in any illegal act described in chapter 794, chapter 800, or chapter 827, or to otherwise engage in unlawful sexual conduct with M.V., contrary to the provisions of Section 847.0135(4)(a), Florida Statutes, against the peace and dignity of the State of Florida.
