AMENDED INFORMATION

CHARGE(S):

COUNT 1: 794.05 - UNLAWFUL SEXUAL ACTIVITY WITH A MINOR

COUNT 2: 794.051 1 - INDECENT, LEWD, OR LASCIVIOUS TOUCHING OF CERTAIN MINORS (DIRECT)

COUNT 3: 827.03(2)(C) - CHILD ABUSE (DIRECT)

R.J. LARIZZA, State Attorney for the Seventh Judicial Circuit of the State of Florida and as such prosecuting attorney for this Court, in the name of and by the authority of the State of Florida charges that:

COUNT 1: On or about February 17, 2025, in the County of FLAGLER and State of Florida, JOSE VALERIO-RODRIGUEZ, who is an unauthorized alien as defined in F.S. 908.11(1)(d), while 24 years of age or older, did engage in oral, anal, or vaginal penetration by, or union with, the sexual organ of X.S., a person 16 or 17 years of age, or JOSE VALERIO-RODRIGUEZ did engage in the anal or vaginal penetration by any other object of X.S., contrary to Florida Statute 794.05 and 775.0848 (1 DEG FEL)(LEVEL 6)

COUNT 2: On or about February 17, 2025, in the County of FLAGLER and State of Florida, JOSE VALERIO-RODRIGUEZ, who is an unauthorized alien as defined F.S. 908.11(1)(d), did, while 24 years of age or older, intentionally touch, in a lewd or lascivious manner, the breasts, genitals, genital area, or buttocks, or the clothing covering them of X.S., a person 16 or 17 years of age, or JOSE VALERIO-RODRIGUEZ did force or entice X.S., to so touch JOSE VALERIO-RODRIGUEZ, contrary to Florida Statute 794.051 and 775.0848 (2 DEG FEL) (LEVEL 4),

COUNT 3: On or about February 17, 2025, in the County of FLAGLER and State of Florida, JOSE VALERIO-RODRIGUEZ, who is an unauthorized alien as defined in F.S. 908.11(1)(d), did knowingly or willfully intentionally inflict physical or mental injury upon X.S., a child, {or} did an intentional act or actively encouraged another to do an act that results or could reasonably be expected to result in physical or mental injury to X.S., a child, contrary to Florida Statute 827.03(2)(c) and (1)(b) and 775.0848. (2 DEG FEL) (LEVEL 6),
