R.J. LARIZZA, State Attorney for the Seventh Judicial Circuit of the State of Florida and as such prosecuting attorney for this Court, in the name of and by the authority of the State of Florida charges that:

COUNT I: PETER JAMES STRICKLAND, on or between April 25, 2017, and July 28, 2022, in the County of FLAGLER and State of Florida, was unlawfully and knowingly in possession or control of or did intentionally view a video which, in whole or in part, PETER JAMES STRICKLAND knew to include any sexual conduct by a child,

to wit: a female child between the ages of 7 and 10 years old performing oral sex on an adult male's penis, contrary to Florida Statute 827.071(5) and 775.0847(2) and (3)(a). (2 DEG FEL)

COUNT II: IN THAT PETER JAMES STRICKLAND, on or between April 25, 2017, and July 28, 2022, in the County of FLAGLER and State of Florida, was unlawfully and knowingly in possession or control of or did intentionally view a video which, in whole or in part, PETER JAMES STRICKLAND knew to include any sexual conduct by a child, to wit: a female child between the age of 5 and 8 years old performing oral sex on an adult male's penis, contrary to Florida Statute 827.071(5) and 775.0847(2) and (3)(a). (2 DEG FEL)

COUNT III: IN THAT PETER JAMES STRICKLAND, on or between April 25, 2017, and July 28, 2022, in the County of FLAGLER and State of Florida, was unlawfully and knowingly in possession or control of or did intentionally view a video which, in whole or in part, PETER JAMES STRICKLAND knew to include any sexual conduct by a child, to wit: an adult male's penis making union with the vagina of a female child between the age of 2 and 4 years old, contrary to Florida Statute 827.071(5) and 775.0847(2) and (3)(a). (2 DEG FEL)

COUNT IV: IN THAT PETER JAMES STRICKLAND, on or between April 25, 2017, and July 28, 2022, in the County of FLAGLER and State of Florida, was unlawfully and knowingly in possession or control of or did intentionally view a video which, in whole or in part, PETER JAMES STRICKLAND knew to include any sexual conduct by a child, to wit: a black and white video of an adult male penetrating the vagina of a female child between the ages of 9 and 12 years old with the adult male's penis, contrary to Florida Statute 827.071(5) and 775.0847(2) and (3)(a). (2 DEG FEL)

COUNT V: IN THAT PETER JAMES STRICKLAND, on or between April 25, 2017, and July 28, 2022, in the County of FLAGLER and State of Florida, was unlawfully and knowingly in possession or control of or did intentionally view a video which, in whole or in part, PETER JAMES STRICKLAND knew to include any sexual conduct by a child, to wit: an adult male rubbing his penis on the mouth of a female child between the ages of 2 and 4 years old, contrary to Florida Statute 827.071(5) and 775.0847(2) and (3)(a). (2 DEG FEL)

COUNT VI: IN THAT PETER JAMES STRICKLAND, on or between April 25, 2017, and July 28, 2022, in the County of FLAGLER and State of Florida, was unlawfully and knowingly in possession or control of or did intentionally view a video which, in whole or in part, PETER JAMES STRICKLAND knew to include any sexual conduct by a child, to wit: an adult female performing oral sex on a female child between the ages of 5 and 8 years old, contrary to Florida Statute 827.071(5) and 775.0847(2) and (3)(a). (2 DEG FEL)

COUNT VII: IN THAT PETER JAMES STRICKLAND, on or between April 25, 2017, and July 28, 2022, in the County of FLAGLER and State of Florida, was unlawfully and knowingly in possession or control of or did intentionally view a video which, in whole or in part, PETER JAMES STRICKLAND knew to include any sexual conduct by a child, to wit: an adult male's penis having union with the vagina of a female child between the ages of 4 and 6 years old, contrary to Florida Statute 827.071(5) and 775.0847(2) and (3)(a). (2 DEG FEL)

COUNT VIII: IN THAT PETER JAMES STRICKLAND, on or between April 25, 2017, and July 28, 2022, in the County of FLAGLER and State of Florida, was unlawfully and knowingly in possession or control of or did intentionally view a video which, in whole or in part, PETER JAMES STRICKLAND knew to include any sexual conduct by a child, to wit: an adult male's penis having union with the vagina of a female child between the ages of 4 and 6 years old and the adult male ejaculating on the child's leg, contrary to Florida Statute 827.071(5) and 775.0847(2) and (3)(a). (2 DEG FEL)

COUNT IX: IN THAT PETER JAMES STRICKLAND, on or between April 25, 2017, and July 28, 2022, in the County of FLAGLER and State of Florida, was unlawfully and knowingly in possession or control of or did intentionally view a video which, in whole or in part, PETER JAMES STRICKLAND knew to include any sexual conduct by a child, to wit: a female child between the age of 4 and 6 years old with an adult male's erect penis in her hand and as the child turns her head to face the camera she spits out the adult male's ejaculate, contrary to Florida Statute 827.071(5) and 775.0847(2) and (3)(a). (2 DEG FEL)

COUNT X: IN THAT PETER JAMES STRICKLAND, on or between April 25, 2017, and July 28, 2022, in the County of FLAGLER and State of Florida, was unlawfully and knowingly in possession or control of or did intentionally view a video which, in whole or in part, PETER JAMES STRICKLAND knew to include any sexual conduct by a child, to wit: an adult male penetrating the vagina of a female child between the ages of 2 and 4 years of age with the adult male's penis contrary to Florida Statute 827.071(5) and 775.0847(2) and (3)(a). (2 DEG FEL)

COUNT XI: IN THAT PETER JAMES STRICKLAND, on or between April 25, 2017, and July 28, 2022, in the County of FLAGLER and State of Florida, was unlawfully and knowingly in possession or control of or did intentionally view a video which, in whole or in part, PETER JAMES STRICKLAND knew to include any sexual conduct by a child, to wit: a female child between the ages of 5 and 8 years of age performs oral sex on an adult male's penis, contrary to Florida Statute 827.071(5) and 775.0847(2) and (3)(a). (2 DEG FEL)

COUNT XII: IN THAT PETER JAMES STRICKLAND, on or between April 25, 2017, and July 28, 2022, in the County of FLAGLER and State of Florida, was unlawfully and knowingly in possession or control of or did intentionally view a video which, in whole or in part, PETER JAMES STRICKLAND knew to include any sexual conduct by a child, to wit: a female child between the ages of 5 and 8 years of age performs oral sex on an adult male's penis contrary to Florida Statute 827.071(5) and 775.0847(2) and (3)(a). (2 DEG FEL)

COUNT XIII: IN THAT PETER JAMES STRICKLAND, on or between April 25, 2017, and July 28, 2022, in the County of FLAGLER and State of Florida, was unlawfully and knowingly in possession or control of or did intentionally view a video which, in whole or in part, PETER JAMES STRICKLAND knew to include any sexual conduct by a child, to wit: a female child between the ages of 5 and 8 years of age performing oral sex on an adult male's penis, contrary to Florida Statute 827.071(5) and 775.0847(2) and (3)(a). (2 DEG FEL)

COUNT XIV: IN THAT PETER JAMES STRICKLAND, on or between April 25, 2017, and July 28, 2022, in the County of FLAGLER and State of Florida, was unlawfully and knowingly in possession or control of or did intentionally view a video which, in whole or in part, PETER JAMES STRICKLAND knew to include any sexual conduct by a child, a female child between the age of 10 and 14 years old putting a small animal's penis in her mouth contrary to Florida Statute 827.071(5) and 775.0847(2) and (3)(a). (2 DEG FEL)

COUNT XV: IN THAT PETER JAMES STRICKLAND, on or between April 25, 2017, and July 28, 2022, in the County of FLAGLER and State of Florida, was unlawfully and knowingly in possession or control of or did intentionally view a video which, in whole or in part, PETER JAMES STRICKLAND knew to include any sexual conduct by a child, to wit: a female child between the ages of 4 and 7 years old performs oral sex on an adult female, contrary to Florida Statute 827.071(5) and 775.0847(2) and (3)(a). (2 DEG FEL)

COUNT XVI: IN THAT PETER JAMES STRICKLAND, on or about between April 25, 2017, and July 28, 2022, in the County of FLAGLER and State of Florida, was unlawfully and knowingly in possession or control of or did intentionally view a video which, in whole or in part, PETER JAMES STRICKLAND knew to include any sexual conduct by a child, to wit: an adult female licks the anus of a female child between the age of 5 and 8 years old, contrary to Florida Statute 827.071(5) and 775.0847(2) and (3)(a). (2 DEG FEL)

COUNT XVII: IN THAT PETER JAMES STRICKLAND on or about between April 25, 2017, and July 28, 2022, in the County of Flagler and State of Florida, did knowingly possess any pornographic image or video of a person engaged in sexual contact with an animal, as defined in F.S. 828.126(1), to wit: a video of a horse engaged in vaginal penetration with an adult Caucasian female, contrary to Florida Statute 828.126(2)(e). (3 DEG FEL)

COUNT XVIII: IN THAT PETER JAMES STRICKLAND on or between April 25, 2017, and July 28, 2022, in the County of Flagler and State of Florida, did knowingly possess any pornographic image or video of a person engaged in sexual contact with an animal, as defined in F.S. 828.126(1), to wit: a video of an adult Caucasian female performing oral sex on a large animal, contrary to Florida Statute 828.126(2)(e). (3 DEG FEL)


COUNT XIX: IN THAT PETER JAMES STRICKLAND on or about between April 25, 2017, and July 28, 2022, in the County of Flagler and State of Florida, did knowingly possess any pornographic image or video of a person

engaged in sexual contact with an animal, as defined in F.S. 828.126(1), to wit: a video image of a male dog mounting an unclothed adult Caucasian female, contrary to Florida Statute 828.126(2)(e). (3 DEG FEL)

COUNT XX: IN THAT PETER JAMES STRICKLAND on or about between April 25, 2017, and July 28, 2022, in the County of Flagler and State of Florida, did knowingly possess any pornographic image or video of a person engaged in sexual contact with an animal, as defined in F.S. 828.126(1), to wit: a video of an adult male penetrating the vagina of a female dog, contrary to Florida Statute 828.126(2)(e). (3 DEG FEL)

COUNT XXI: IN THAT PETER JAMES STRICKLAND on or between April 25, 2017, and July 28, 2022, in the County of Flagler and State of Florida, did knowingly possess any pornographic image or video of a person engaged in sexual contact with an animal, as defined in F.S. 828.126(1), to wit: a video of a horse penetrating the vagina of an adult Caucasian female laying on her back, contrary to Florida Statute 828.126(2)(e). (3 DEG FEL)
