On September 20th, 2016 at approximately 0426 hours, I, D/S B. Wall was conducting a patrol of the E Section of Palm Coast when Corporal R. Emery requested another unit to respond to a suspicious incident near the intersection of Eagle Harbor Trail and Eagle Crest Path.

I arrived on scene and walked around the area with Corporal Emery who asked me if I smelled anything and I stated that I smelled a foul odor in the area which was consistent with that of rotting flesh. Corporal Emery stated that it smelled like decaying human remains. Corporal Emery and I narrowed the area down to a vacant wooded lot located at the corner of Eagle Harbor Trail and Eagle Crest Path where we thought the odor was emitting from. We entered the woods and began searching for anything that would be emitting the odor. Corporal Emery and I located what appeared to be an adult male lying face down in the woods approximately 10 yards into the wood line.

A crime scene was established and D/S J. Rodenborn began a crime scene log. I used crime scene tape to cordon off the entire wooded lot on the corner of Eagle Harbor Trail and Eagle Crest Path.

The investigation was turned over to Detective E. Glasgow of the Flagler County Sheriff's Office.
