On 12/10/18 at approximately 12:00 PM I, Deputy Alecrim was contacted by Dean Erin Davis at Flagler Palm Coast High School, located at 5500 E 100 Hwy, Palm Coast FL 32164, in reference to a juvenile incident. Dean Erin Davis advised that a teacher reported to her that two students had been chatting on the school issued computers. Dean Erin Davis advised that the teacher reported that the students made statements which stated that "WERE GONNA GET AWAY WITH MURDUR TONIGHT". Dean Erin Davis advised that the two students who had the conversation were [REDACTED] and [REDACTED].

Upon investigation of the chat logs, which were provided by Flagler Palm Coast High School Information Technology, it was determined that additional chats were made threatening a teacher ([REDACTED]).

In the chat conversation between [REDACTED] and [REDACTED] chats: "My nigger teacher ([REDACTED]) is pissing me off" and "Im in a bad mood already. I swear im gonna stomp on her fucking face and smash her weave into the ground". [REDACTED] responded with LMFAOOOOOO (laugh my fucking ass off). [REDACTED] then chats: "Im about t stomp out of this class, Like fucking throw the desk at her ([REDACTED]) and leave. [REDACTED] responds: "Kill her" ([REDACTED] [REDACTED] responded back: "I will". [REDACTED] later chats: "I won't get in trouble, you know why? To which [REDACTED] responds: "Cuz niggers don't have rights". [REDACTED] then asks: "When are we killing her, lmfaooooo". [REDACTED] responds: "Tonight. I already know her address", "Okay I will", "1:35am?" and "Okay okay good. We have a time set". [REDACTED] then goes on to chat: "WERE GONNA GET AWAY WITH MURDUR TONIGHT". [REDACTED] responds by saying: "Thye gonna give you a medal for killing a nigger". [REDACTED] chats: "Well its not really murder. Were doing the world an amazing thing". The chat continues as [REDACTED] continues to tell racist jokes.

I made contact with [REDACTED] and she advised that the conversation was a joke and she no intentions of harming anyone. [REDACTED] advised that the chat took place on 12/10/18 during the second period of the school day which runs from 9:31 am to 10:58 am. [REDACTED] advised that she was joking when talking about wearing bright clothing and light up shoes, prior to mentioning getting away with "murdur"(murder). [REDACTED] advised that the joke was made because she was mad at a teacher because she wasn't allowed to make up the work. [REDACTED] was adamant about the chat being a joke and her having no intention of harming anyone. [REDACTED] advised that she stated she knows [REDACTED] address in the chat; however, she stated she was just saying that as a joke and doesn't really know her address.

I made contact with [REDACTED] and he advised that the conversation was a joke between him and [REDACTED] [REDACTED] advised that he had no intentions of harming anyone. [REDACTED] advised that they we joking and if anyone asked any student they would understand it was a joke. [REDACTED] stated that the way he spoke with [REDACTED] on the computer is the way that students speak to each other.

Corporal Hristokopolous and Sgt. Miller interviewed both subjects in the presence of School Admin and determined that there was no credible threat. Contact was also made with Legal Counsel and it was determined that there was no probable cause at this time for arrest. It should be noted that there is a joking manner to the conversation. The threats made in the conversation do not appear to be credible. There will be no charges filed at this time.

A Field Threat Assessment was completed for [REDACTED] and [REDACTED].

[REDACTED] was advised of the situation and issued a case card. [REDACTED] was advised to contact the
